PART I GENERAL

Commencement and Citation

 This Order shall come into operation on the 7th day of March 2024 and may be cited as the West Oxfordshire District Council (OFF-STREET PARKING PLACES) No.1 ORDER 2021 (VARIATION No. 1) Order 2024.

Interpretation

2. In this Variation Order, except where the context otherwise requires, the following expressions have the meanings respectively assigned to them:

"the Principal Order" means the WEST OXFORDSHIRE DISTRICT COUNCIL (OFF-STREET PARKING PLACES) NO.1 ORDER 2021;

- 3. Except where the context requires otherwise, any reference in this Order to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order
- 4. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment
- 5. The Interpretation Act 1978 shall apply for the interpretation of this Order

PART II

Amendment of the Principal Order

- 6. The First Schedule of the Principal Order shall be amended in relation to row 11 ("11. WITNEY Woolgate Car Park ") Parking Place so that Column 1 shall read: *"11. WITNEY Woolgate Car Park Zones A-F Plan number 10"*
- 7. The First Schedule of the Principal Order shall be further amended as follows:
 - a. To insert a new row 11A set outs as follows:


